SECTION 3: HAZARD IDENTIFICATION

Emergency Overview: White, cotton cloth pad presaturated with isopropanol. Liquid is flammable. Liquid will irritate eyes and skin under repeated or prolonged exposure. Breathing high concentrations of product vapor may produce drowsiness and a headache.

Potential Health Effects:

Eyes: Liquid contents of this product are irritating and can cause pain, tearing, reddening and swelling accompanied by a stinging sensation.

Skin: Prolonged contact with liquid contents may cause skin irritation.

Ingestion: Harmful if swallowed. Irritating to mouth, throat and stomach. May cause vomiting.

<u>Inhalation:</u> Harmful if inhaled. High concentrations of liquid vapors in immediate area can displace oxygen and can cause dizziness, unconsciousness, and even death with longer exposure. Keep people away from such vapors without self-contained breathing apparatus.

SECTION 4: FIRST AID MEASURES
