

Vehicles: 2007 Endeavor equipped with sunroof

Purpose: On some affected vehicles, the headliner may sag at the sides of the sunroof opening due to foam blocks pushing this area down. When this condition occurs, the cut edge of the headliner becomes visible as it is pushed past the sunroof opening trim. In order to correct this condition, and prevent unnecessary replacement of the headliner or sunroof opening trim, use the following repair procedure. For this condition,

make repairs to BOTH sides of the sunroof opening even if it is sagging at only one side.
