

With routine care and maintenance, your BEVCO chairs and backless stools should provide years of comfortable and trouble-free seating. Occasional light cleaning along with proper use and maintenance is all that is necessary. Follow the general guidelines below for best results and preservation of the warranty:

STANDARD FABRIC

CARRINGTON, DORAL, EVANSTON, INTEGRA,
LEXINGTON, VERSA, WESTMOUND

- ▶ Regularly clean chair fabric by vacuuming or light brushing.
- ▶ Test cleaning product in an inconspicuous area first to guard against color bleeding or fabric shrinkage is recommended.
- ▶ All commercial cleaning agents and solvents may be used:
 - Water-based stains should be treated with water-based cleaning agents.
 - Oil-based stains should be treated with a solvent cleaner.

ESD FABRIC

CARRINGTON, DORAL, EVANSTON, INTEGRA,
LEXINGTON (V8), VERSA

- ▶ Regularly clean chair fabric by vacuuming or light brushing.
- ▶ Spot treat with mild soap and water or ESD-safe cleaner.



STANDARD VINYL

CARRINGTON, DORAL, EVANSTON, INTEGRA,
VERSA, WESTMOUND

- ▶ Use a soft, non-abrasive cleaning cloth or sponge.
- ▶ Always rub gently and rinse with a water damped cloth/sponge.
- ▶ For light soiling, use a solution of 10% household liquid dish soap in warm water.
- ▶ For heavy soiling, use a 1:1 solution of Formula 409® or Fantastik® and water.
- ▶ For more difficult stains, use a solution of household bleach (10% bleach and 90% water).

ESD VINYL

CARRINGTON, DORAL, EVANSTON, INTEGRA,
VERSA, WESTMOUND

- ▶ Use a soft, non-abrasive cleaning cloth or sponge.
- ▶ Use any ESD-safe cleaner for non-porous surfaces.
- ▶ Always rub gently and rinse with a water damped cloth/sponge.

POLYURETHANE

(Standard, ESD, CR and ESD/CR)

BREVA, DURA, EVERLAST, ERGOLUX, ERGOLUX JR.,
SIT-STANDS, SPRINGDALE, VERSA-P

- ▶ Avoid harsh cleaning products and solvent chemicals.
- ▶ Spot clean with mild soap and water.
On ESD or ESD/CR Polyurethane, be sure to use an ESD-Safe Cleaner.

PROPER USE & MAINTENANCE

- ✔ Use this product only for its intended purpose as an office or industrial seating product.
- ✔ Do not stand on footring, it is meant as a footrest and is not designed to support full body weight.
- ✔ Do not overtighten handwheels located on chair back, underneath the seat, or the footring adjustment.
- ✔ Check that all bolts, screws, and knobs are tightly secured every three months or as needed.
