Recommendation: For frequent or prolongued soldering processes, use of a local exhaust system to avoid exposure to thermal decomposition products. Reflow oven are typically vented outside or use a specially designed filtered recirculation system.

Section 12: Ecological Information

Ecological classifications are based on the IMDG/GHS criteria in conjunction with ecotoxicological data from our suppliers, the European Chemical Agency database (http://echa.europa.eu), and other reliable sources.

Contains particles of silver and copper of less than a 1 mm but more than 100 nm (larger than nanoparticles), which release ionic levels that is very toxic to the environment. While massive silver and copper are insoluble in water, their powders is considered sufficiently soluble to give rise to an ecological hazard by EU regulations. The classification that follows takes into account to chronic aqueous toxicity of category 1 (M = 10 for silver and M = 1 for copper) in EU.

Based on available data for tin, 2-(2-hexyloxyethoxy) ethanol, and hydrogenated rosin, the GHS aqueus toxicity classification criteria are not met.
