

Intended Use:

ProSpray wipes are a tuberculocidal, intermediate level disinfectant meeting CDC Guidelines and the OSHA Bloodborne Pathogens Standard for cleaning and disinfecting when blood and body soils may be present. They are intended for use in healthcare and other settings. In the absence of visible soils this product may be used as a "one-step" cleaner-disinfectant.

Product Capabilities:

Kills a broad range of microorganisms in three minutes: Mycobacterium tuberculosis var. bovis (TB), Staphylococcus aureus, Staphylococcus aureus - MRSA HA, Salmonella enterica, Pseudomonas aeruginosa, Trichophyton mentagrophytes (Fungus), HIV-1* and Herpes simplex virus types 1 & 2*.

Note 1: The CDC Guideline for Disinfection and Sterilization in Healthcare Facilities, 2008 continues to emphasize use of intermediate-level disinfectants: "...these surfaces should be disinfected between patients with an intermediate-disinfectant (i.e., EPA-registered disinfectant with tuberculocidal claim)". Also: "Potency against M. tuberculosis has been recognized as a substantial benchmark. Any germicide with a tuberculocidal claim on the label is considered capable of inactivating a broad spectrum of pathogens, including such less resistant organisms as bloodborne pathogens (e.g., Hepatitis B virus, Hepatitis C virus and HIV)." CDC Guidelines for Infection Control in Dental Healthcare Settings - 2003. MMWR 2003;52(No.RR-17): p. 63.

Cleans and Disinfects:

Effective disinfection relies on effective removal of soil. Bloodborne viruses and other dangerous organisms stay viable longer in residual surface soils. ProSpray wipes are ideal for both steps with no need for separate products. Surfactants in ProSpray wipes effectively remove blood and residual soils from a variety of surfaces.

Safer for Surfaces:

ProSpray wipes are a water based disinfectant that meets equipment manufacturers' guidelines for a formula free of alcohol, ammonium and bleach actives. ProSpray wipes will not crack, haze or corrode surfaces commonly found in healthcare settings such as vinyls, plastics and metal fittings. ProSpray wipes also reduce exposure of staff and equipment to solvents used in many disinfectant products. Solvents may boost antimicrobial action but cause equipment damage and chemical sensitivity.

ProSpray wipes are ideal for disinfection of electronic devices, keyboards, control membranes, sensors and cords. The wipes format reduces potential damage from excess liquids seeping into electronic fittings. Consult manufacturer's instructions for specific applications and precautions.

Use Precautions:

A slight soap film may occur upon repeated application of ProSpray wipes due to detergents in the formula. Simply wipe surfaces off at least weekly with plain tap water and paper towels.

Rinse garments or surfaces where ProSpray wipes are used prior to application of any bleach product.

Store ProSpray wipes away from direct heat sources and direct sunlight. Avoid freezing during shipping or storage.
