SECTION VIII - SPECIAL PROTECTION INFORMATION

RESPIRATORY PROTECTION: In outdoor or open areas, use NIOSH/MSHA approved organic vapor cartridge type respirator to remove solid airborne particles of over spray during spray application. In

restricted ventilation areas use NIOSH/OSHA approved organic vapor cartridge type respirator designed to remove a combination of particles and vapor.

VENTILATION: In confined spaces mechanical ventilation is required to keep the air contaminant concentration below current applicable OSHA permissible exposure units.

PROTECTIVE GLOVES: Impervious type required for long or repeated exposure.

EYE PROTECTION: Use safety eye wear to protect against splash of liquids.

OTHER PROTECTIVE EQUIPMENT: Prevent prolonged skin contact with contaminated clothing.

HYGIENIC PRACTICES: Wash hands before eating, smoking or using washroom facilities.
