4. FIRST AID MEASURES

Inhalation:	Move to fresh air. If not breathing, give artificial respiration. If breathing is difficult, give oxygen. Get medical attention.

5. FIRE FIGHTING MEASURES

Extinguishing media:	Water spray (fog), foam, dry chemical or carbon dioxide. A solid stream of water may scatter molten product.

6. ACCIDENTAL RELEASE MEASURES

7. HANDLING AND STORAGE

Handling:	Make sure containers are properly grounded before use or transfer of material.
