4. FIRST AID MEASURES

First Aid Measures by likely routes of exposure Move to fresh air. If breathing is difficult, give oxygen. If not breathing, give Inhalation:

artificial respiration. If symptoms develop and persist, get medical attention. Skin contact: Do not pull bonded skin apart. Soak in warm soapy water. Gently peel apart

using a blunt instrument. If skin is burned due to the rapid generation of heat by a large drop, seek medical attention. If lips are bonded, apply warm water to the lips and encourage wetting and pressure from saliva in mouth. Peel or roll lips apart. Do not pull lips apart with direct opposing force.

Eye contact: Immediately flush with plenty of water for at least 15 minutes. Get medical

attention. If eyelids are bonded closed, release eyelashes with warm water by covering with a wet pad. Do not force eye open. Cyanoacrylate will bond to eye protein and will cause a lachrymatory effect which will help to debond the adhesive. Keep eye covered until debonding is complete, usually within 1-3 days. Medical attention should be sought in case solid particles of polymerized cyanoacrylate trapped behind the eyelid caused abrasive

damage.

Ingestion: Ensure breathing passages are not obstructed. The product will polymerize

rapidly and bond to the mouth making it almost impossible to swallow. Saliva will separate any solidified product in several hours. Prevent the patient from

swallowing any separated mass.

Most important symptoms and effects (acute

and delayed):

The most important known symptoms and effects, both acute and delayed, are described in Section 11: Toxicological Information.

Indication of any immediate medical attention / special treatment needed:

Surgery is not necessary to separate accidentally bonded tissues. Experience has shown that bonded tissues are best treated by passive, non-surgical first aid. If rapid curing has caused thermal bums they should be treated symptomatically after adhesive is removed.

5. FIRE FIGHTING MEASURES
