This tool is for handheld use only. Do not use extensions or accessories.

HOTRO Model HRD614

Remove cap to replace battery.

Do not use screwdriver blade to pry. Plastic cap will be damaged if pounded on or hit

Excessive force when tightening or loosening screws may damage screwdriver blade.

The following safety instructions MUST be followed when using the HOTROD ™ SAFETY SCREWDRIVER:

- 1. Never work on live lines. If HOTROD™ indicates a live line, turn off line power before continuing.
- 2. Always test product on KNOWN live voltage, before use, to verify proper operation. Handle must be held in hand for proper operation.
- 3. Never use product near or on lines. that may exceed 600 volts.
- 4. Blade must physically contact CONDUCTOR to indicate live lines. This unit only provides proximity indication at butt end of handle.
- 5. Replace HOTROD™ immediately if insulation, handle or cap appears damaged in any way.
- 6. Never use adapters, extensions, or accessories with this tool.
- *120 volt outlets may be tested by inserting blade into hot side of outlet. Also check neutral in case of miswiring.
