Depending on the color intensity desired, 0.5 to 4.0 % pigment paste should be added. The concentration should be kept at a minimum. In individual cases, an excess of color paste may slow down the curing characteristics. Customers may produce other colors by mixing pigment pastes. Suggestions for formulations can be provided on request.

This product is available in 20 kg pail and 1kg tin.
